- A Title I Parent Night will be held in September to inform the parents about the Title I program.
- The school will provide parents of participating children with timely information, in a language
 parents can understand, about the Title I program, parent programs, meetings, and other school
 related activities.
- Parent meetings, including parent-teacher conferences, will be held at different reasonable times during the day in order to accommodate the needs and schedules of those involved.
- A school-parent compact will be developed with parents outlining how parents, the entire school staff, and the students will share in the responsibility for improved student achievement.
- The school will provide materials and training to help parents work with their children to improve their children's achievement and to foster parent involvement.
- In order for parents to participate in school-related meetings and training sessions, Title I funds may be used to pay reasonable and necessary expenses associated with parent involvement activities. Parent professional development conferences will be offered.
- The school will provide assistance to parents of participating children with a description and
 explanation of the curriculum in use at the school, the various forms and methods of academic
 assessment, the State's academic content standards and student achievement standards, local
 academic assessments, and how to work with teachers to improve the academic achievement of
 their children.
- The school and Parent Advisory Committee will conduct an annual evaluation of the content and effectiveness of this parental involvement policy. An end-of-the-year needs assessment will be conducted for parent input and suggestions. Also, a student survey will be conducted at the end of the school year.
